#### Workforce Investment Act\*

The federal Workforce Investment Act (WIA) is a federally funded program that assists employers in obtaining skilled and productive employees; expands the available pool of skilled workers whose skills match current job opportunities; and measures program achievements in terms of customer outcomes and increased local accountability. Ohio has 31 comprehensive, full-service One-Stop sites, and 59 satellite sites throughout 20 local workforce development areas, with at least one site in every Ohio county. #### Child Support

The Columbiana County Child Support Enforcement Agency establishes paternities and obtains, enforces, and collects child support funds for children.

\$17,717,673 in IV-D child support was collected by the county during 2009.

#### Food Assistance (FA)

The Food Assistance program is designed to raise nutritional levels, to expand buying power and to safeguard the health and well-being of individuals and families whose gross monthly income is within 130 percent of the federal poverty guideline. Half of all recipients are children.

### Family Services

#### Child Care

Ohio counties provide child care services and early learning opportunities that families need to succeed at work and school. Through state and federal funding, families whose income is at or below 150 percent of the federal poverty guideline can receive payment for all or part of their monthly child care expenses while parents work or attend job training/educational activities. A family may remain eligible until income increases to 200 percent of the federal poverty guideline.

### Medical Assistance

Ohio offers a variety of assistance programs to give those with limited resources access to basic medical care. The most comprehensive of these is Medicaid, the federally funded, state-administered program that reimburses doctors and health-care facilities for providing services to eligible individuals with low income.

#### Health Care Statistics

##### In Columbiana County:

- 35.2%** of hospital visits occurred outside the county (2009)
- 54.6%** of all births were paid by Medicaid (2007)
- 54.9%** of mothers receiving Medicaid had two or more risk factors for poor birth outcomes (2007)

#### Medicaid Enrollment and Expenditures

Medicaid is the state and federally funded program that pays for health care services for eligible low-income people of all ages, including children, pregnant women, families, older adults and Ohioans with disabilities. Medicaid services are delivered via contracted health care providers, ensuring that Medicaid consumers get access to needed services, such as physician visits, hospital inpatient care, prescription drugs and home health services.
