The Delivery Premium Payment Dates column is intended to show the actual date the CFC Managed Care Plan should expect the net payment to be made by electronic funds transfer (EFT). The detailed claim information for delivery payments is included on the HIPAA 820 files that are produced at the end of the month.

Please note that EFTs may be received in MCP accounts on any Thursday during a month. Usually these are adjustments made after the previous months' HIPAA 820 was already produced. The detailed claim information for such payments is also included on the HIPAA 820 for the payment cycle in which the adjustment was paid.
