This letter is to inform you that the undersigned represents Penske Logistics, LLC ("Penske"). Penske maintains an operating location at 300 Phillipi Road, Columbus, Ohio 43228. This letter constitutes written notice to you pursuant to the WARN Act legislation.

At present, Penske employs approximately fifty-three (53) individuals at its Columbus, Ohio location. Due to a contract cancellation, Penske will permanently close its Columbus, Ohio location effective with the close of business on July 31, 2009. That closure will result in the permanent layoff of all of the individuals identified on the attached Exhibit.

We deeply regret having to provide you with this notification, however, due to this loss of business cancellation at our Columbus, Ohio operation, Penske has no alternative. If you should have any questions regarding this matter, do not hesitate to contact me.

Notice of Closing or Substantial Layoff

The Worker Adjustment and Retraining Notification Act of 1988 (P.L. 100-379) requires certain employers to give at least 60 days notice to layoffs or plant/facility closings. Notice must be given to the State Dislocated Employee Unit, local government and employees. Failure to do so makes an employer liable to each aggrieved employee for back pay for each day of violation and benefits. In addition, any such employer shall be subject to a civil penalty of not more than \$500 for each day of violation.
