Purpose

- ODJFS Office of Family Assistance ensures that the administration of child care programs provides for the health, safety, and well-being of children while in care.
- Important component: to ensure all Ohioans with young children have access to high quality child care.
- For many low-income families, equal access is assured in the form of child care tuition subsidies.
- Since the enactment of the Child Care and Development Block Grant Act, ODJFS has utilized a child care market rate survey to establish the current market rates for child care programs across Ohio by provider type, child age group, and region.



Survey Development

- Used past MRS as a starting point
- Revised with discussion with ODJFS project team
- Draft questions and proposed survey language were reviewed by:
 - The ODJFS Child Care Advisory Council and
 - Representatives of the Early Childhood Advisory Council



Sampling Frame

- Providers in Contact Effort (7,142)
 - Child Care Center 4,064
 - ❖ Type A FCC Home 240
 - ❖ Type B FCC Home 2,571
 - ❖ Approved Day Camp 52
 - ❖ ODE Licensed Preschool 92
 - ❖ ODE Licensed School Age Child Care 123



Methodology

- Online survey programmed by SRG and tested by SRG and ODJFS project teams
- Email contacts, with letters mailed to those with no valid email addresses
- FAQ webpage and toll-free number
- Contact efforts occurred from November 8,
 2018 January 11, 2019

Nonresponse Prompting

- Two waves of nonresponse prompting calls to encourage response and answer questions
 - November 26, 2018 to December 7, 2018 (all nonresponding providers)
 - ➤ January 3, 2019 to January 11, 2019 (Type A and Type B Home providers)



Response Rates

- ❖ 2018 Overall MRS response rate: 52.5% (3,752)
 - Child Care Center 62.5%
 - ❖ Type A FCC Home 45.4%
 - ❖ Type B FCC Home 38.0%
 - ❖ Approved Day Camp − 51.9%
 - ❖ODE Preschool 55.4%
 - ❖ODE School Age Child Care − 40.7%



Rate Sheets

- SRG requested rate sheets from every 3rd provider responding to the survey
 - > Rates sheets used for quality assurance
 - Some providers selected did not charge rates (e.g., Head Start programs)
 - Some printed their ODJFS portal information (calls made to confirm these rates)
- SRG requested 1,240 rate sheets and received 673 (response rate of 54.3%)



Quality Assurance

- 2018 MRS rate data compared to rate sheet rates and ODJFS portal rates
- Data was converted to match (e.g., weekly to weekly and daily to daily)
- Error rates calculated for each age cohort and service period (PT, FT, HR)

* Error Rate % =
$$100 \times \left(\frac{\text{rate entered on survey}}{\text{rate from (rate sheet or ODJFS portal)}} - 1 \right)$$

Error rate < 5% was considered a match</p>

Market Rate Structure Analysis

- Goal of MRS is to define the various rate settings, based on:
 - Child care service categories
 - Age categories (infant, toddler, preschool, school-age, school-age during summer)
 - Service period categories:
 - Full-time (25 to 60 hours per week)
 - Part-time (7 to less than 25 hours per week)
 - Hourly (less than 7 hours per week)
 - Location
 - County-based grouping (clusters)



Determining County Clusters

- Mathematical technique for grouping cases
- Establishing components to use for clusters (what explains the most variance in provider rates in different counties)
 - ➤ Goal: reduce 10 rate categories (full-time and part-time for all five age categories) into smaller set of factors
 - Principal component analysis
 - > Two components identified:


- Average of all rates: explained 77% of variance
- ➤ Age groups (infant/toddlers and school-age): explained 10%
- Only first component used in cluster analysis

Cluster Analysis

- Four counties excluded from the cluster analysis:
 - Monroe and Morgan (no MRS data)
 - Van Wert and Delaware (outliers)
- Cluster algorithms
 - Hierarchical Produced ineffective results (2 clusters)
 - ➤ K-means cluster smallest number of clusters for which variability in factor (overall average rate) is explained by cluster membership: **3 clusters**

Rate Distributions

- 180 sets of rate percentiles were created
 - ➤ 45 state-wide (3 provider types × 15 child care service categories)
 - ➤ 135 cluster-level (3 provider types × 15 child care service categories × 3 county clusters)
- Rates were weighted by the enrollment capacity for each subgroup
- Percentiles: 10th, 15th, 20th, 25th, 30th, 35th, 40th, 45th, 50th, 55th, 60th, 65th, 70th, 75th, 80th, 85th, 90th, and 95th



Rate Distributions

- Weekly rates had very little skewness no correction needed
- Past rate distributions were calculated from weighted means and standard deviations to create distributions on a normal curve
- 2018 distributions were actual weighted rates at each percentile
